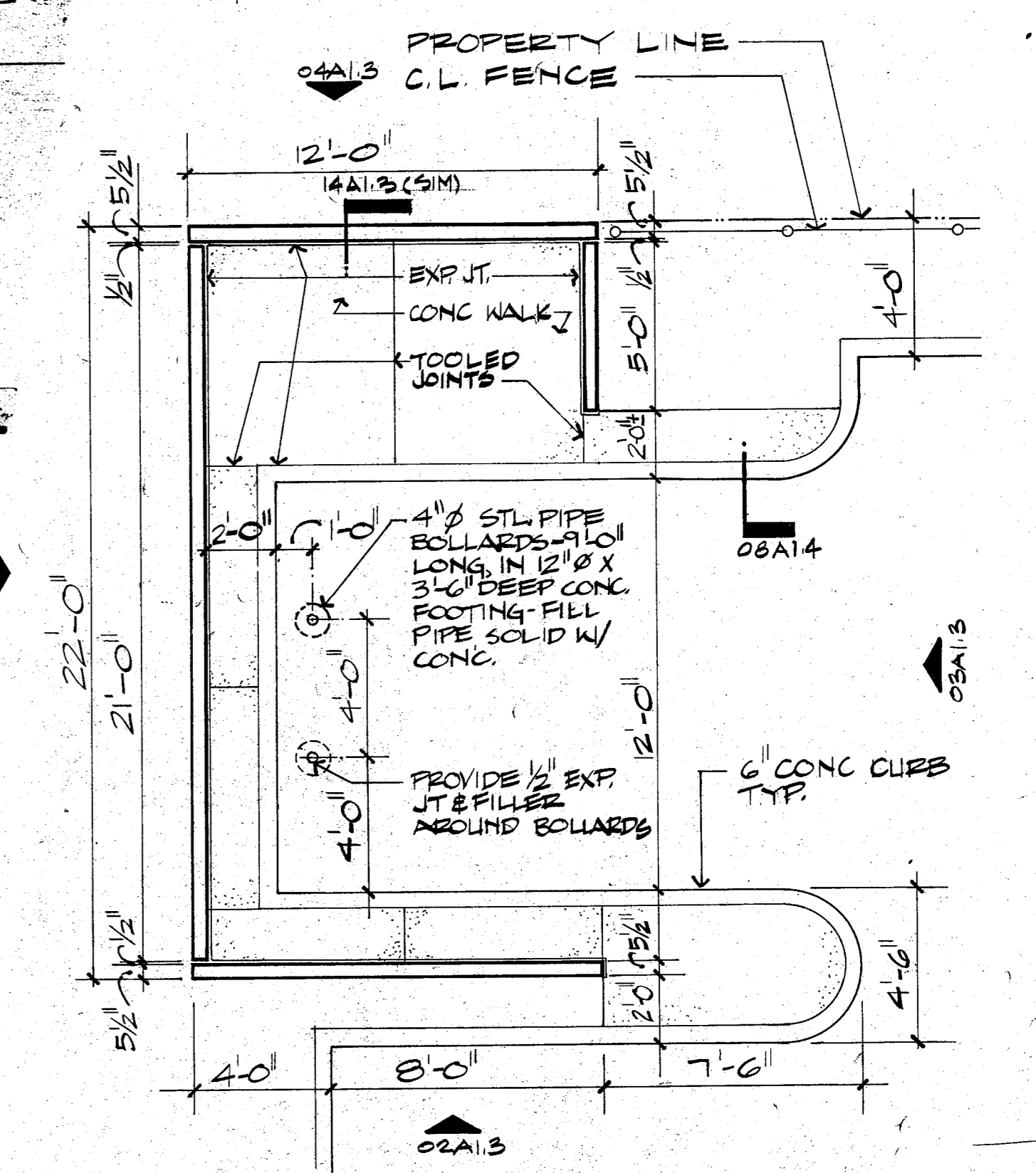


**06 FILLER GAP DETAIL CONC.**

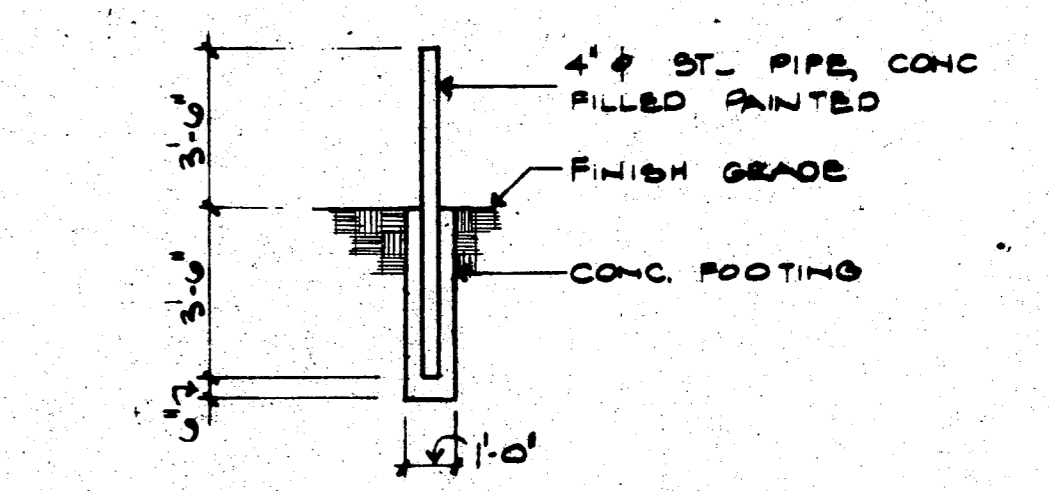


13 ENTRANCE PLAN

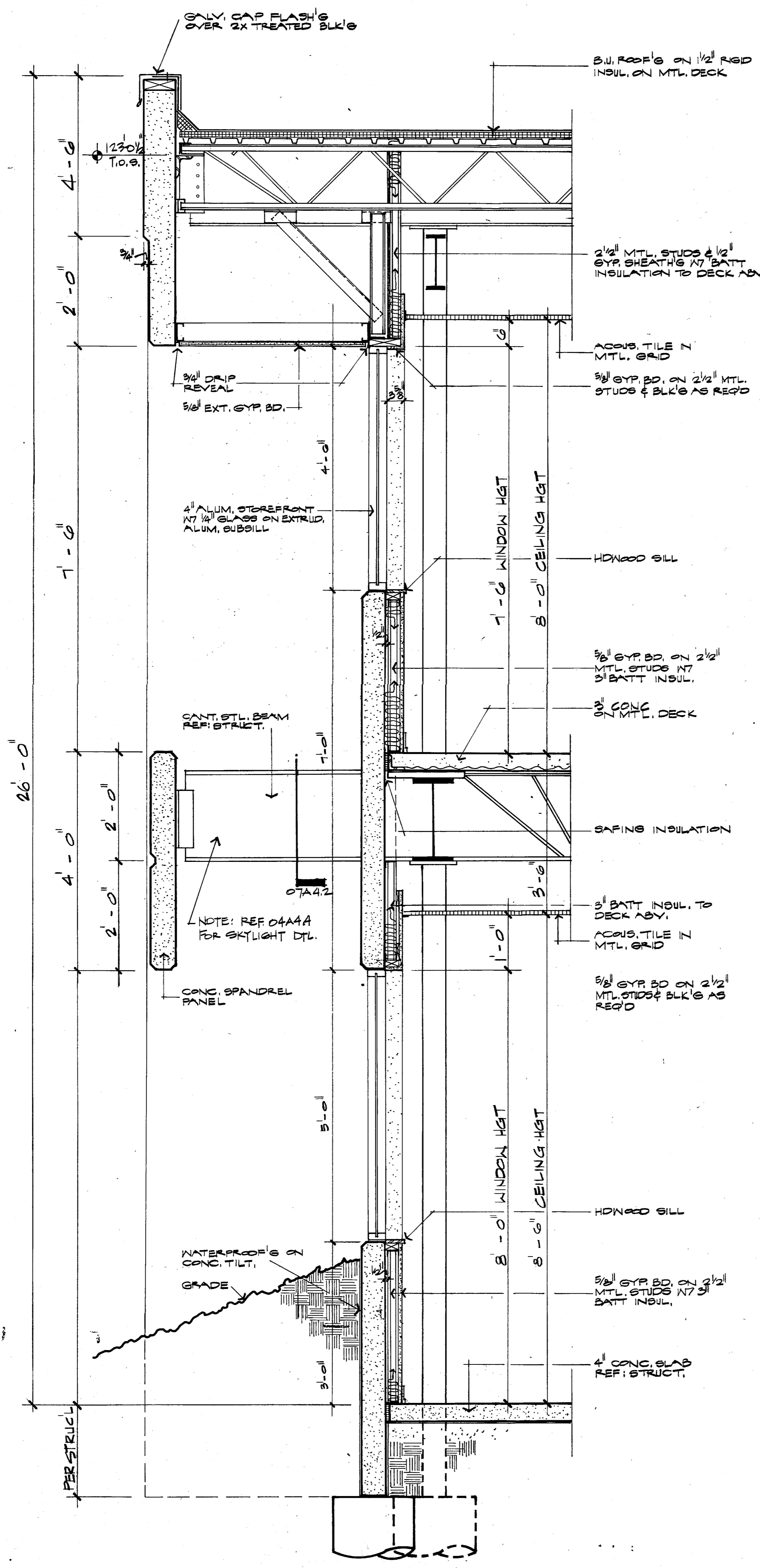


**01 EAST/WEST BUILDING CROSS SECTION LOOKING NORTH**

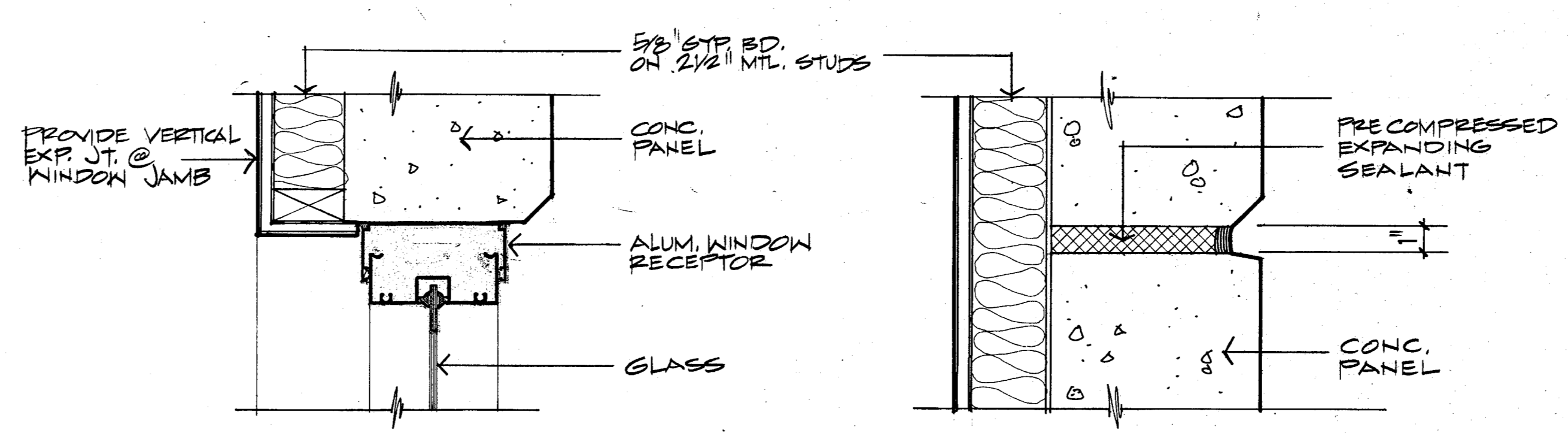

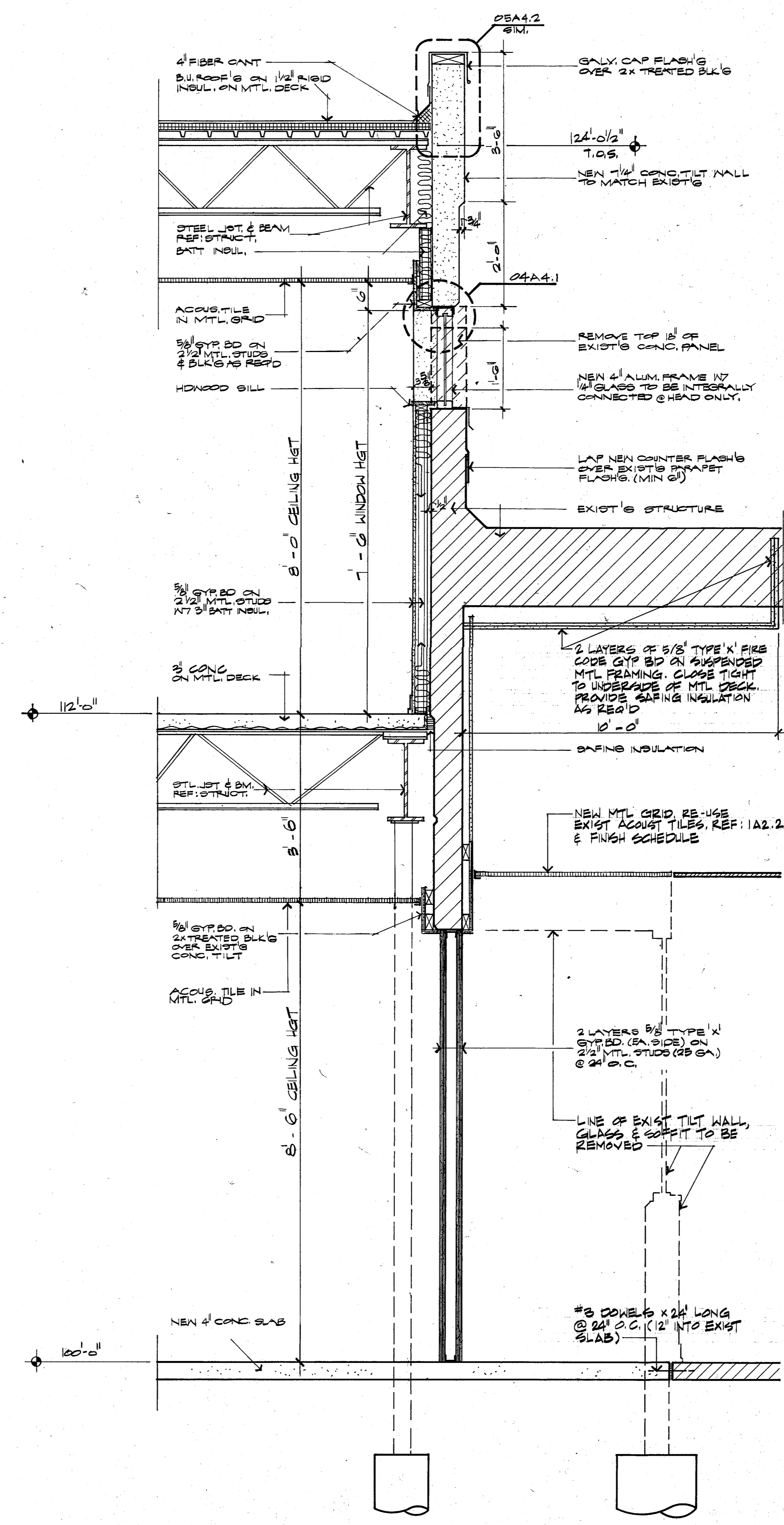

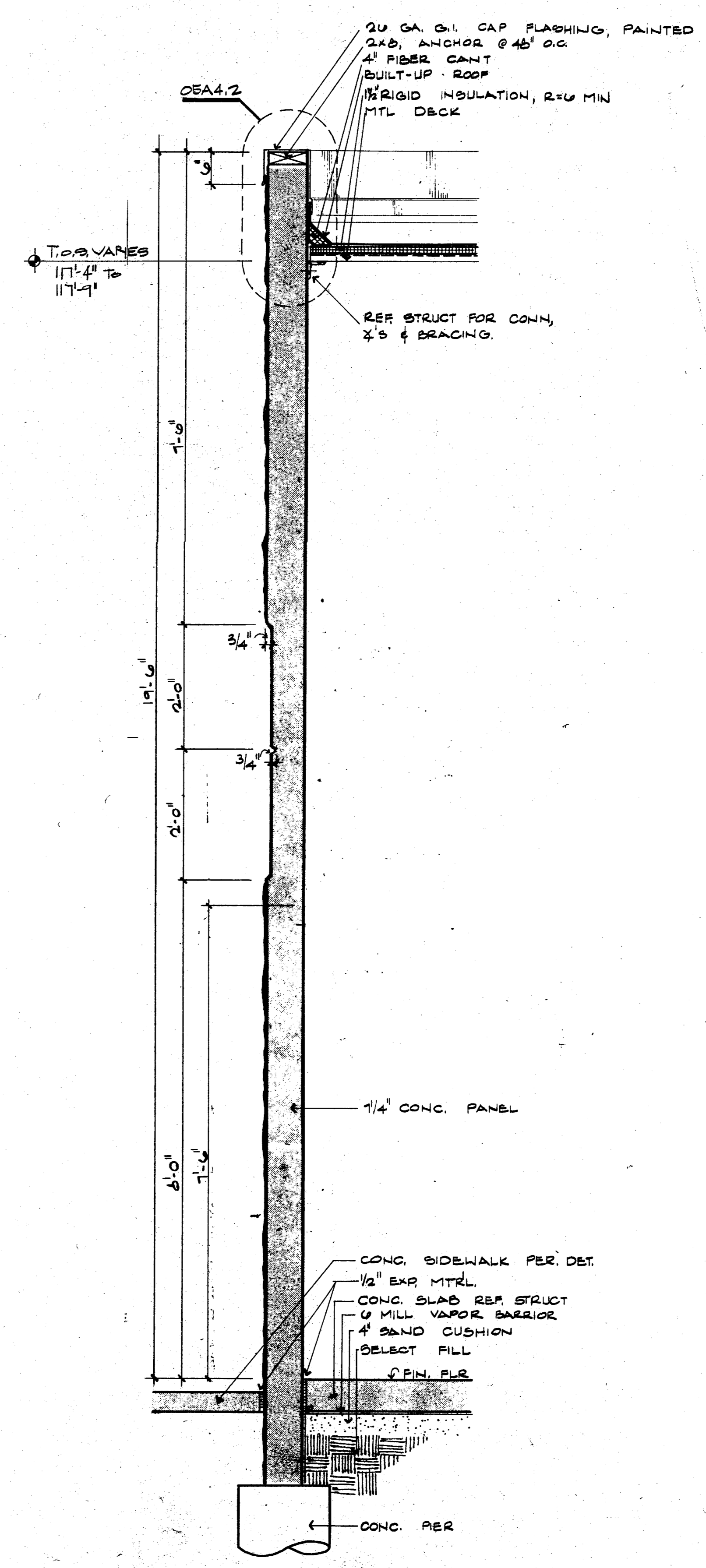


**04 HEAD DETAIL**

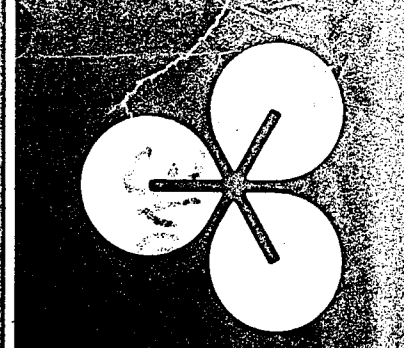


01 SITE PLAN - ELECTRICAL / PLUMBING

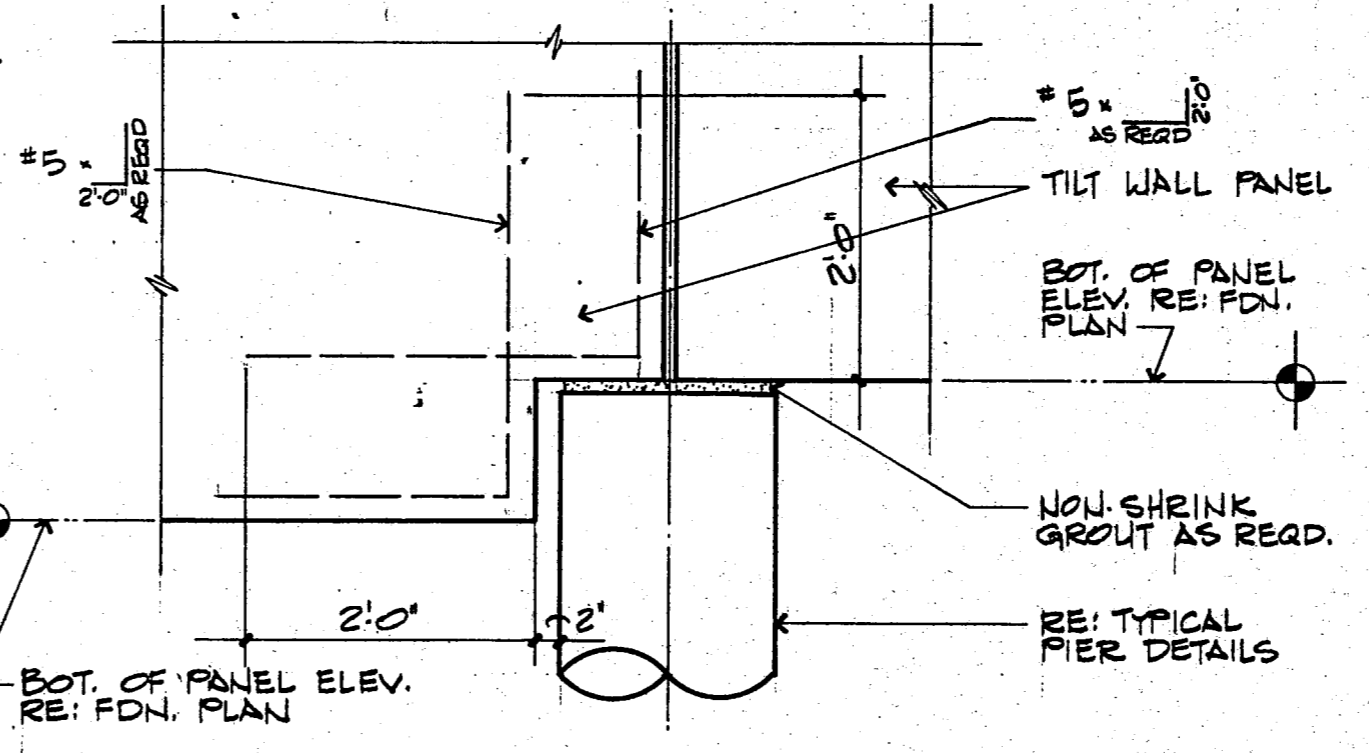

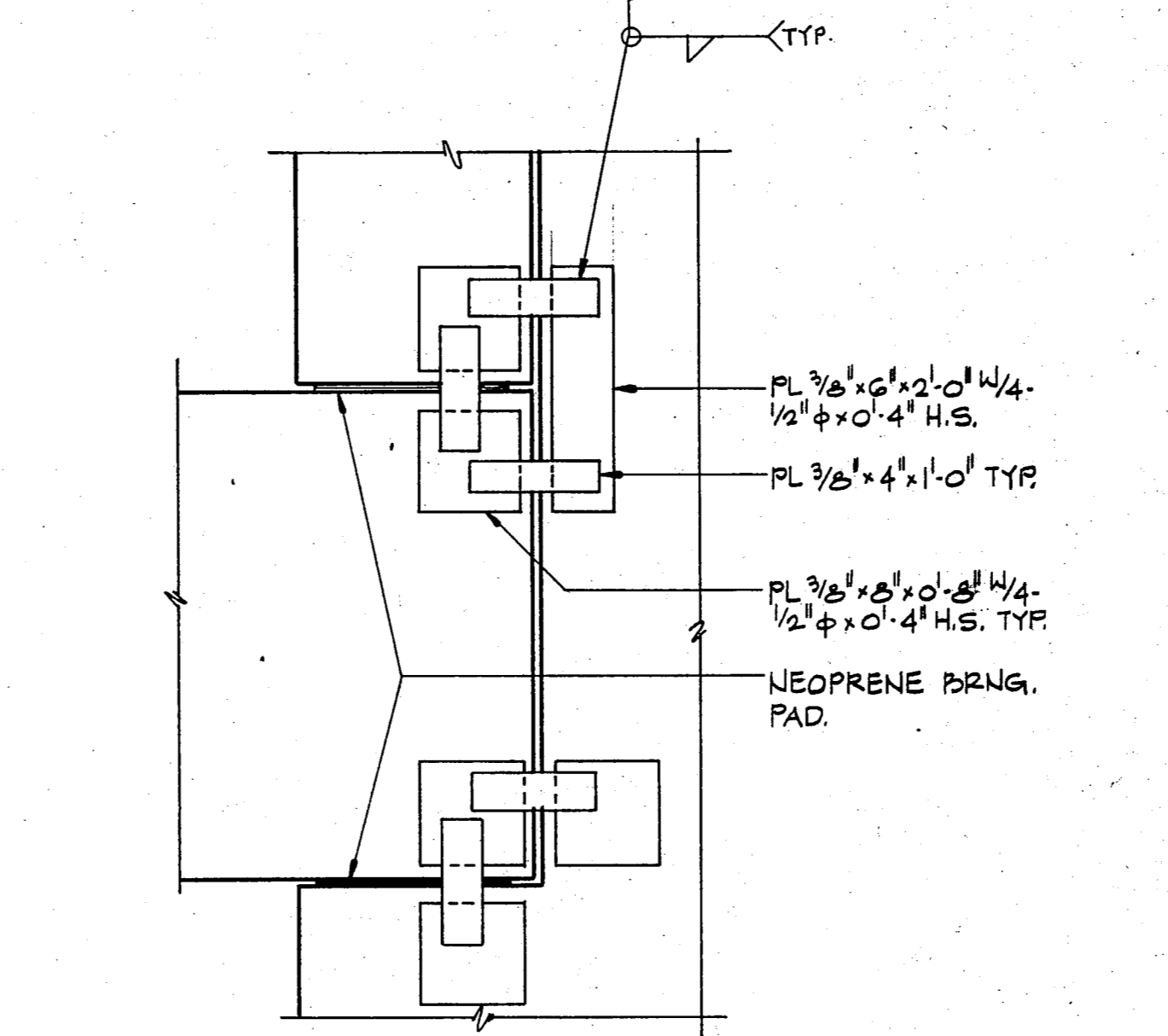
TYPICAL TILT WALL PANEL ELEVATION

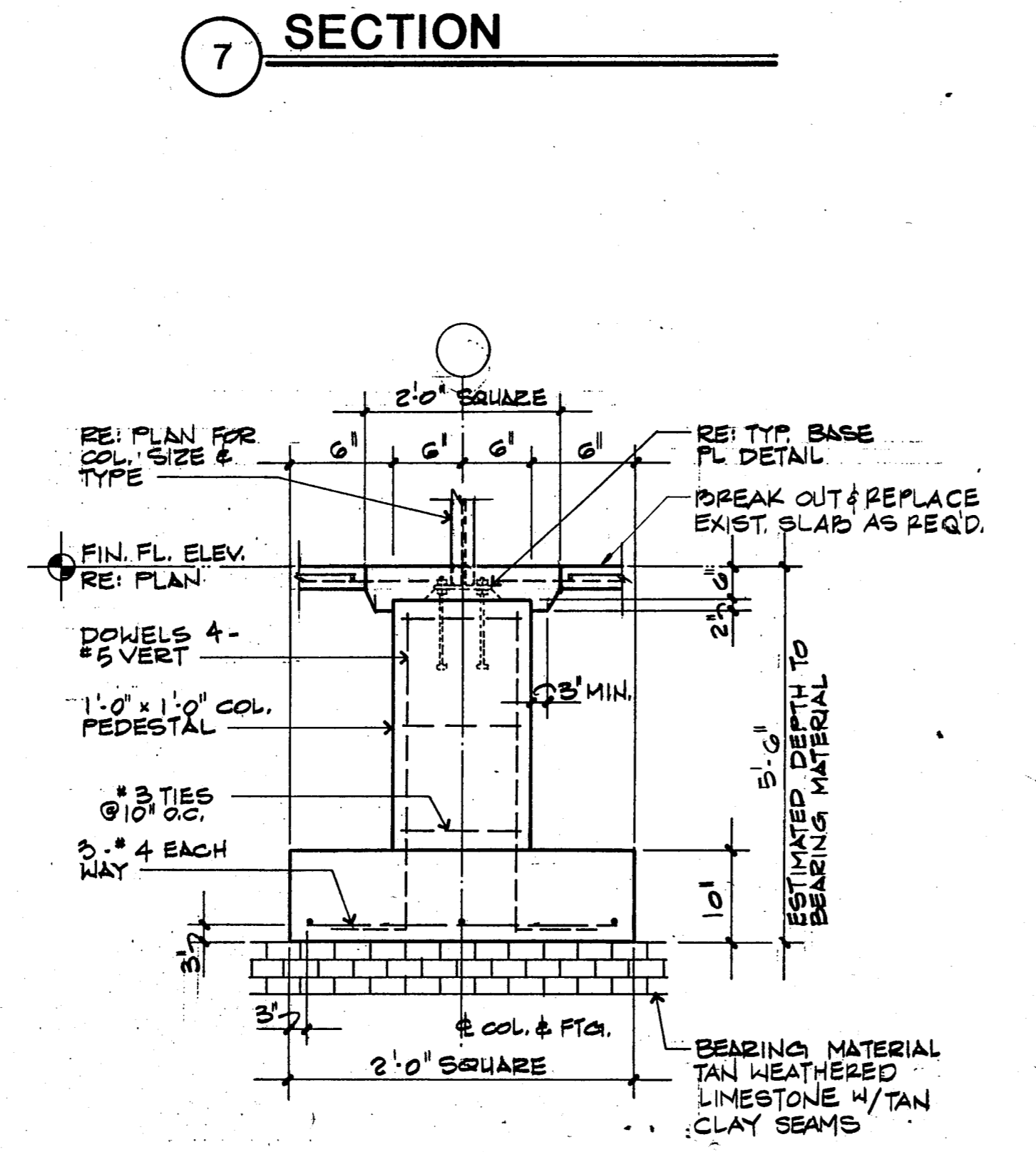
9 TYPICAL STORAGE BIN TILT - UP PANELS
