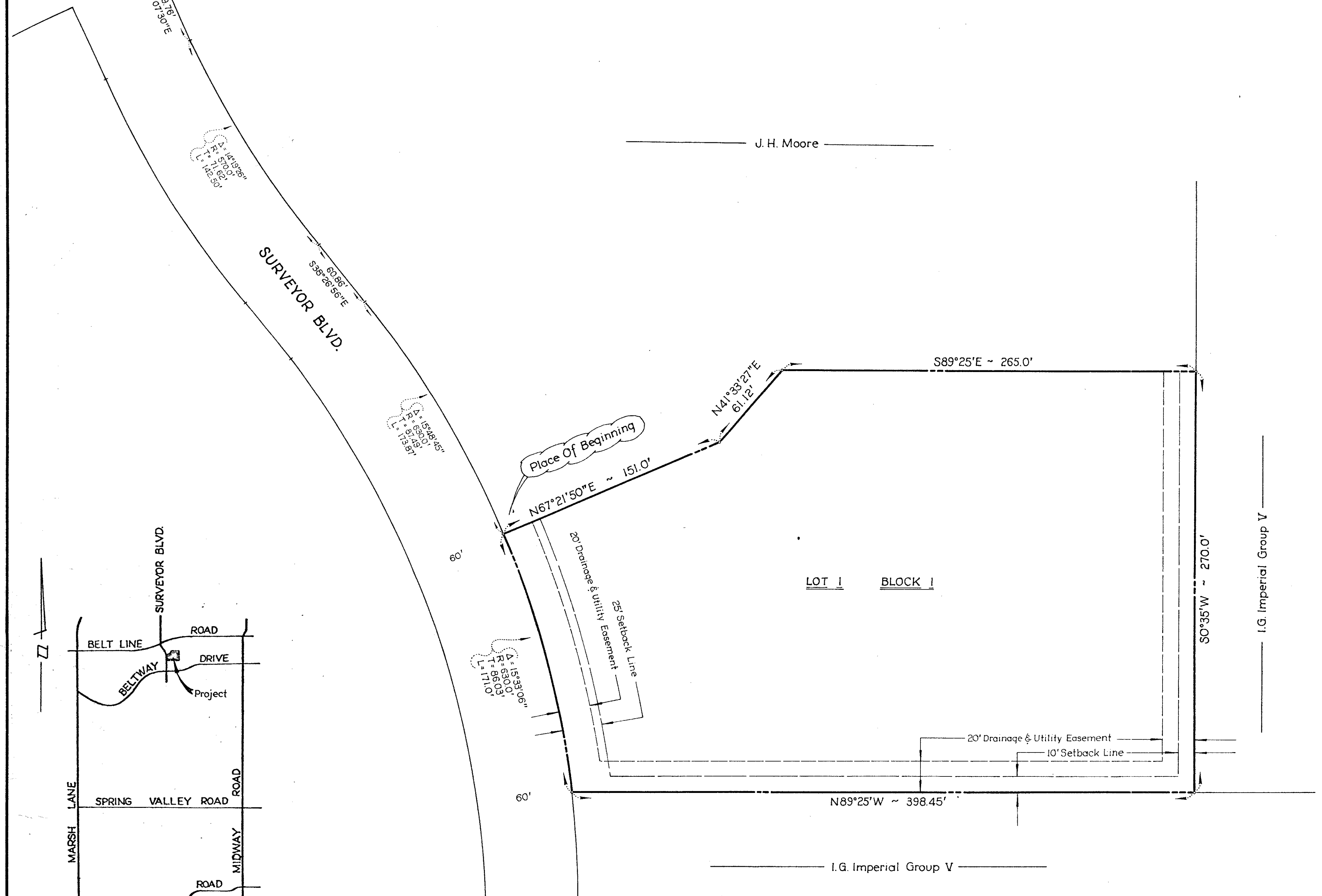


BELT LINE ROAD
(100' R.O.W.)

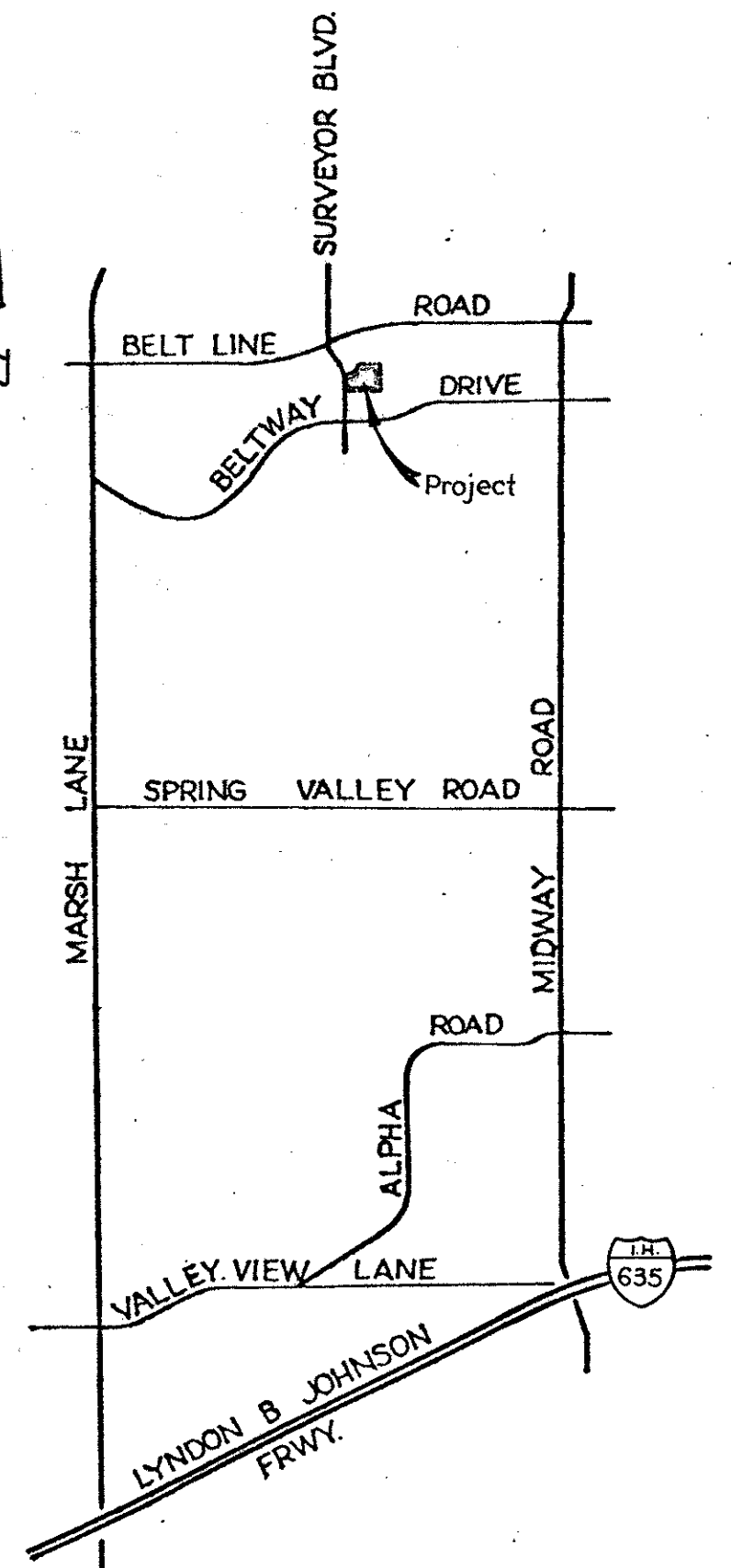

OWNER'S CERTIFICATE

WHEREAS, LEVITZ FURNITURE CO. OF TEXAS, is the owner of a tract of land situated in the Thomas L. Chenoweth Survey, Abstract No. 273, City of Addison, Dallas County, Texas, and being more particularly described as follows:

COMMENCING at the intersection of the Southerly line of Belt line Road (a 100' R.O.W.), and the Easterly line of Surveyor Blvd. (a 60' R.O.W.), a point for corner;

THENCE Southerly leaving said Southerly line of Belt Line Road, and proceeding along said Easterly line of Surveyor Blvd., the following:

S 24° 07' 30" E, a distance of 49.76 feet to the beginning of a curve to the left having a central angle of 14° 19' 16" and a radius of 570.0 feet, a point for corner;

Southerly around said curve, a distance of 142.50 feet to a point for corner;

S 38° 26' 56" E, a distance of 60.06 feet to the beginning of a curve to the right having a central angle of 15° 48' 45" and a radius of 630.0 feet, a point for corner;

Southerly around said curve, a distance of 173.87 feet to the PLACE OF BEGINNING, an iron stake for corner;

THENCE N 67° 21' 50" E, leaving said Easterly line of Surveyor Blvd., a distance of 151.0 feet to an iron stake for corner;

THENCE N 41° 33' 27" E, a distance of 61.12 feet to an iron stake for corner;

THENCE S 89° 25' E, a distance of 265.0 feet to an iron stake for corner;

THENCE S 0° 35' W, a distance of 270.0 feet to an iron stake for corner;

THENCE N 89° 25' W, a distance of 398.45 feet to a point on the abovementioned Easterly line of Surveyor Blvd., an iron stake for corner;

THENCE along said Easterly line of Surveyor Blvd., and around a curve to the left having a back tangent bearing of N 7° 05' 04" W, a central angle of 15° 33' 06", a radius of 630.0 feet, a distance of 171.0 feet to the PLACE OF BEGINNING and containing 2.387 acres of land.

NOW THEREFORE KNOW ALL MEN BY THESE PRESENTS: THAT, LEVITZ FURNITURE CO. OF TEXAS does hereby adopt this plat designating the hereinabove-described property as LEVITZ FURNITURE CO. OF ADDISON, TEXAS, an addition to the City of Addison, Dallas County, Texas, and does hereby dedicate to the City and public use forever the streets and easements shown thereon.
