

WHEREAS, VICTOR LISSIAK, JR, AND RALPH HAMM, JR., ARE THE OWNERS OF A TRACT OF LAND SITUATED IN THE CITY OF ADDISON, DALLAS COUNTY, TEXAS, AND BEING PART OF THE ELISHA FIKE ABSTRACT 478, AND ALSO BEING PART OF A 14.077 ACRE TRACT OF LAND CONVEYED TO ROBERT W. COLLINS, TRUSTEE, BY DEED DATED JUNE 21, 1973, AND RECORDED IN VOLUME 73128, PAGE 0613, AND ALL OF A 26.1091 ACRE TRACT OF LAND CONVEYED TO ROBERT W. COLLINS, TRUSTEE, BY DEED DATED JUNE 21, 1973, AND RECORDED IN VOLUME 73122, PAGE 0836, OF THE DEED RECORDS OF DALLAS COUNTY, AND BEING MORE PARTICULARLY DESCRIBED AS FOLLOWS:

BEGINNING AT A POINT FOR CORNER WHICH IS 419.78 FEET DUE EAST OF THE INTERSECTION OF THE EASTERLY LINE OF MIDWAY ROAD (60 FEET WIDE) AND THE NORTHERLY LINE OF BELTWAY DRIVE (60 FEET WIDE);

THENCE DUE NORTH , 240.0 FEET TO A POINT FOR CORNER;

THENCE DUE EAST, 100.0 FEET TO A POINT FOR CORNER;

THENCE DUE SOUTH, 240.0 FEET TO A POINT FOR CORNER ON THE NORTHERNY LINE OF BELTWAY DRIVE;

THENCE DUE WEST ALONG SAID NORTHERLY LINE OF BELTWAY DRIVE, 100.0 FEET TO THE POINT OF BEGINNING AND CONTAINING 0.551 ACRES (24000 SQ. FT.)

NOW THEREFORE, KNOW ALL MEN BY THESE PRESENTS

THAT, VICTOR LISSIAK, JR., AND RALPH HAMM, JR, DO. HEREBY ADOPT THIS PLAT DESIGNATING THE
JEREIN DESCRIBED PROPERTY AS TRACT VII BELTWAY OFFICE PARK, AN ADDITION TO THE CITY OF ADDISON,
TEXAS. THE EASEMENTS SHOWN THEREON ARE HEREBY RESERVED FOR THE PURPOSES AS INDICATED. NO
BUILDINGS, FENCES, TREES, SHRUBS, OR OTHER IMPROVEMENTS OR GROWTHE SHALL BE CONSTRUCTED,
RECONSTRUCTED, OR PLACED UPON, OVER OR ACROSS THE EASEMENTS AS SHOWN. SAID EASEMENTS OR
GROWTHS SHALL BE CONSTRUCTED, RECONSTRUCTED, OR PLACED UPON, OVER OR ACROSS THE EASEMENTS AS
SHOWN. SAID EASEMENTS BEING HEREBY RESERVED FOR THE MUTUAL USE AND ACCOMMODATION OF ALL
PUBLIC UTILITIES USING OR DESTRING TO USE SAME. ALL AND ANY PUBLIC UTILITY SHALL HAVE THE
RIGHT TO REMOVE AND KEEP REMOVED ALL OR PARTS OF ANY BUILDINGS, FENCES, TREES, SHRUBS OR OTHER
IMPROVEMENTS OR GROWTHS WHICH IN ANY WAY MAY ENDANGER OR INTERFERE WITH THE CONSTRUCTION,
WAINTENANCE OR EFFICIENCY OF ITS RESPECTIVE SYSTEM ON THE EASEMENTS AND ALL PUBLIC UTILITIES
SHALL AT ALL TIMES BAVE THE FULL RIGHT OF INGRESS AND EGRESS TO OR FROM AND UPON SAID EASEMENTS
FOR THE PURPOSE OF CONSTRUCTING, RECONSTRUCTING, INSPECTIVE, PATROLLING, MAINTAINING AND
ADDING TO OR REMOVING ALL PARTS OF ITS RESPECTIVE SYSTEMS WITHOUT THE NECESSITY AT ANY TIME OF
PROCURING THE PERMISSION OF ANYONE. ALL PUBLIC UTILITY SHALL HAVE THE RIGHT OF INGRESS AND
EGRESS TO PRIVATE PROPERTY FOR THE PURPOSE OF READING METERS AND ANY MAINTENANCE AND SERVICE
REQUIRED OR ORDINARILY PERFORMED BY THAT UTILITY.
