WHEREAS, FOLSOM INVESTMENTS, INC., IS THE OWNER OF A TRACT OF LAND IN THE WILLIAM LOMAX SURVEY, ABSTRACT 792, STRUCTED IN THE CITY OF ADDISON, DALLAS COUNTY, TEXAS, AND BEING MORE PARTICULARLY DESCRIBED AS FOLLOWS:

BEGINNING AT A POINT, SAID POINT BEING MORTH 47° 59' 26" E, 50.0 FEET FROM THE INTERSECTION OF THE SOUTH RIGHT-OF-WAY LINE OF DALLAS PARKWAY (100.0 FEET WIDE), AND THE CENTERLINE OF WESTGROVE DRIVE, THENCE ALONG WESTERLY RIGHT-OF-WAY OF WESTGROVE DRIVE, SOUTH 42° 0' 34" WEST, 200.00 FEET;
THENCE SOUTH 30° 41' 56" WEST, 101.98 FEET;
THENCE SOUTH 42° 0' 34" WEST, 22.00 FEET;
THENCE SOUTHERLY ALONG CURVE TO THE RIGHT HAVING A RADIUS OF 270.00 FEET, A CENTRAL ANGLE
OF 90° AND A TANGENT OF 270.00 FEET, AN ARC DISTANCE OF 185.52 FEET;

THENCE NORTH 47° 59' 26" WEST, 300.00 FEET;
THENCE NORTH 42° 0' 34" EAST, 591.99 PEET TO A POINT FOR CORNER;
THENCE SOUTH 47° 59' 26" EAST, 550.00 FEET TO THE POINT OF BEGINNING AND CONTAINING 7.27 ACRES (316796 5.F.)

NOW THEREFORE KNOW ALL HEN BY THESE PRESENT:

THAT, FOLSON INVESTMENTS, INC., ACTING HEREIM BY AND THROUGH ITS DULY AUTHORIZED OFFICERS, DOES HEREBY ABOUT THIS PLAT DESIGNATING THE HEREIN DESCRIBED PROPERTY AS BEST TREE TOWERS, AN ADDITION TO THE CITY OF ADDISON, TEXAS. THE EASEMENTS SHOWN THEREON ARE HEREBY RESERVED FOR THE PURPOSES AS INDICATED. NO BUILDINGS, FENCES, TREES, OR OTHER IMPROVEMENTS OR GROWTHS SHALL BE CONSTRUCTED. RECONSTRUCTED, OR PLACED UPON, OVER OR ACROSS THE EASEMENTS AS SHOWN. SAID EASEMENTS OR GROWTHS SHALL BE CONSTRUCTED, RECONSTRUCTED, OR PLACED UPON, OVER OR ACROSS THE EASEMENTS AS SHOWN. SAID EASEMENTS BEING HEREBY RESERVED FOR THE HUTUAL USE AND ACCOMMODATION OF ALL PUBLIC UTILITIES USING OR DESIRING TO USE SAME. ALL AND ANY PUBLIC UTILITY SHALL HAVE THE RIGHT TO REMOVE AND KEEP REMOVED ALL OR PARTS OF ANY BUILDINGS, FENCES, TREES, SHRUBS OR OTHER IMPROVEMENTS OR GROWTHS WHICH IN ANY WAY MAY ENDANGER OR INTERFERE WITH THE CONSTRUCTION, MAINTENANCE OR EFFICIENCY OF ITS RESPECTIVE SYSTEM ON THE EASEMENTS AND ALL PUBLIC UTILITIES SHALL AT ALL TIMES HAVE THE FULL RIGHT OF INGRESS AND EGRESS TO OR FROM AND UPON SAID EASEMENTS FOR THE PURPOSE OF CONSTRUCTING, RECONSTRUCTING, INSPECTING. PATROLLING, MAINTAINING AND ADDING TO OR REMOVING ALL PARTS OF ITS RESPECTIVE SYSTEMS WITHOUT THE NECESSITY AT ANY TIME OF PROCURING THE PERMISSION OF ANYONE. ALL PUBLIC UTILITY SHALL HAVE THE RIGHT OF INGRESS AND EGRESS TO PRIVATE PROPERTY FOR THE PURPOSE OF READING METERS AND ANY MAINTENANCE AND SERVICE REQUIRED OR ORDINARILY PERFORMED BY THAT UTILITY.
