er, am the owner of a tract of land situated in the ABSTRACT NO. 923 in the City of Addison, Dallas County, of a tract of land conveyed to Surveyor Resources, Inc. Volume 71153, Page 0063 in the Deed Records of Dallas being more particularly described by metes and bounds as for corner in the South line of Billy Mitchell Drive (street), as dedicated by plat recorded in Volume 72211, Records of Dallas County, Texas, said point being 937.00 along the East and the South line of Billy Mitchell Drive to the intersection of the North line of Linbergh Drive (a street) with said East line of Billy Mitchell Drive; and South line of Billy Mitchell Drive for a distance of feet for corner; distance of 205.00 feet to an iron rod for corner; distance of 233.96 feet to an iron rod for corner; distance of 205.00 feet to a point for corner in said South Drive, same being the PLACE OF BEGINNING, square feet or 1.1010 acres of land.

ALL WRITTEN IN THESE PRESENTS:

I set this plat as BILLY MITCHELL ADDITION, an addition to Dallas County, Texas; and do hereby dedicate to the public use the streets and alleys shown thereon for all public purposes of the City of Addison and its assigns to lay, install, operate, move and reconstruct any and all public utilities including water lines, sanitary sewer lines, drainage and storm sewer lines, telephone poles and lines, electrical power lines. The right of the City of Addison to establish grades of streets and alleys is hereby granted and all claims for damages in reason of changing the present surface of said streets and alleys are hereby waived.

segments shown on the plat are hereby granted and dedicated and reserved for mutual use and accommodation of the City of Addison and all public bodies desiring to use or using the same for public utility purposes including but limited to water lines, sanitary sewer lines, drainage and storm sewer lines and lines, telephone poles and lines, gas lines, electrical power lines, purtenances. All said any public utility and the City of Addison shall cause right to remove and keep removed all or part of any residences, buildings, trees, shrubs or other improvements, growths or obstructions which may way endanger or interfere with the construction, maintenance, operation or efficiency of the respective utility in, on or under said easement strips. The City of Addison and all public utilities shall at all times have the full right,ress and express to and from and upon said easement strips for the purpose of constructing, reconstructing, inspecting, patrolling, maintaining and removing all or part of its respective system, without the necessity of obtaining or procuring the permission of anyone.
