OWNER'S CERTIFICATE

STATE OF TEXAS COUNTY OF DALLAS

WHEREAS, HOUSEMAN PROPERTIES, INC., a Texas corporation, and DONELSON M. HOUSEMAN are the owners of a tract of land in the W.H. Witt Survey, Abstract No. 1609, and located in the City of Addison, Dallas County, Texas and being more particularly described as follows:

Beginning at the intersection of the west line of Midway (formerly known as Dooley Road) Road (a 100-foot right-of-way) with the north line of Lindbergh Drive (a 60-foot right-of-way);

THENCE, West, 199.94-feet along the north line of Lindbergh Drive to a point for corner;

THENCE, North, 516.33-feet to a point for corner in the City Limit Line between the City of Addison and the City of Carrollton, Texas;

THENCE, S.89°50'17"E., 198.96-feet along the said City Limits Line, to a point for corner in the west line of Midway Road;

THENCE, \$.00°06'35'E., 515.77-feet along the west line of Midway Road to the Point of Beginning and Containing 102,929 square feet or 2.363 acres of land.

NOW, THEREFORE, KNOW ALL MEN BY THESE PRESENTS:

THAT HOUSEMAN PROPERTIES, INC. AND DONELSON M. HOUSEMAN, do hereby adopt this plat designating the herein described property as HOUSEMAN LINDBERGH-MIDWAY ADDITION, an addition to the City of Addison, Texas, and do hereby dedicate to the public use forever the streets and alleys shown thereon. The easements shown thereon are hereby reserved for the purposes as indicated. The utility and fire lane easements shall be open to the public, fire and police units, garbage and rubbish collection agencies and all public and private utilities for each particular use. The maintenance of paving on the utility and fire lane easements is the responsibility of the property owner. No buildings, fences, trees, shrubs or other improvements , or growths shall be constructed, reconstructed, or placed upon, over or across the easements as shown. Said easements being hereby reserved for the mutual use and accomodation of all public utilities using or desiring to use same. All, and any public utility shall have the right to remove and keep removed all or parts of any buildings, fences, trees, shrubs or other improvements or growths which in any way may endanger or interfere with the construction, maintenance, or efficiency of its respective systems on the easements for the purpose of constructing, reconstructing, inspecting, patrolling, maintaining and adding to or removing all or parts of its respective systems without the necessity at any time of procuring the permission of anyone. Any public utility shall have the right of ingress or egress to private property for the purpose of reading meters and performing any maintenance and service required or ordinarily performed by that utility.

This plat approved subject to all ordinances, rules, regulations and resolutions of the City of Addison, Texas.
