

THENCE SOUTH, leaving said Creek and entering a branch, and passing a 1/2—inch iron rod with cap set at a distance of 186.50 feet, in all, a distance of 261.50 feet to a point in the center of said branch for corner (not monumentable);

THENCE along the center of said branch, South 46°02'00" West, a distance of 124.00 feet to a point for corner (not monumentable);

THENCE continuing along the center of said branch, South 05°49'17" West, a distance of 61.00 feet to a point in the north line of Celestial Road (not monumentable);

THENCE along the north line of Celestial Road, South 87°38′57" West, passing a 5/8"—inch iron rod with cap at a distance of 60.00 feet, in all, a distance of 175.00 feet to the POINT OF BEGINNING and containing 2.3388 acres of land, more or less.
