


MIDWAY ROAD



## OWNER CERTIFICATE

WHEREAS, R. Jack Ayres, Jr., Trustee, is the owner of a tract of land situated in the City of Addison and being in the Elisha Pike Survey, Abstract No. 478 and also being part of Beltway Office Park, Tract III and being a part of the same tract of land as described in deed to R. Jack Ayres, Jr., Trustee recorded in Volume 83006, Page 4048 of the Deed Records of Dallas County, Texas and being more particularly described as follows:

BEGINNING at an iron rod for corner in the southerly line of Beltway Drive (60 feet wide), said point being due East a distance of 612.00 feet from the intersection of the easterly line of Midway Road (as widened) and the south-easterly line of said Beltway Drive;

THENCE due East along the southerly line of said Beltway Drive, a distance of 10.78 feet to an iron rod being the beginning of a curve to the left;

THENCE in a northeasterly direction continuing along the southerly right-of-way line of said Beltway Drive and along the said curve to the left, having a radius of 602.96 feet, a central angle of 7°33' 00" and an arc length of 79.45 feet to an iron rod for corner and the end of said curve to the left;

THENCE due South a distance of 255.73 feet to an iron rod for corner in the southerly line of said Beltway Office Park, Tract III;

THENCE due West along the southerly line of said Beltway Office Park, Tract III, a distance of 90.00 feet to an iron rod for corner;

THENCE due North a distance of 250.50 feet to the POINT OF BEGINNING and containing 22,683 square feet, more or less, or 0.5207 acre.

SAVE AND EXCEPT, HOWEVER, the western most 10 feet of the hereinabove described tract which is an exclusive ingress and egress easement granted to owner.

NOW THEREFORE, KNOW ALL MEN BY THESE PRESENTS:

That, R. Jack Ayres, Jr., Trustee, being the owner does hereby adopt this plat designating the hereinabove described property as "ROYAL CENTER", an addition to the City of Addison, Dallas County, Texas and do hereby dedicate to the public use forever the easements shown thereon. No buildings, fences, trees, shrubs or other improvements or growths shall be constructed, re-constructed or placed upon, over or across the utility easements as shown. Said utility easements being hereby reserved for the mutual use and accommodation of all public using or deserving to use same.

All and any public utility shall have the right to remove and keep removed all or parts of any buildings, fences, trees, shrubs or other improvements or growths which in any way endanger or interfere with the construction, maintenance or efficiency of its respective system on the utility easements and all public utilities shall at all times have the full right of ingress and egress to and from and upon the said utility easements for the purpose of construction, reconstruction, inspecting, patrolling, maintaining, and adding to or removing, all or parts of its respective systems without the necessity at any time of procuring the permission of anyone. Any public utility shall have the right of ingress and egress to private property for the purposes of reading meters and any maintenance and service required or ordinarily performed by that utility.

This plat approved subject to all plating ordinances, rules, regulations and resolutions of the City of Addison, Texas.


