COUNTY OF DALLAS WHEREAS I, Paul Lewis, an the owner of a tract of land situated in the W. H. WITT SURVEY, ABSTRACT NO. 1609 in the City of Addison, Dallas County, Texas and being part of a tract of land conveyed to Surveyor Recourses, Inc. by deed filed in Volume 71153, Page 0063 in the Deed Records of Dallas County, Texas and being more particularly described by metes and bounds as follows: BEGINNING at the intersection of the North line of St. Louis and Southwestern

a 100.00 foot right of way as widened by plat recorded in Volume 72211, Page 0119 of the Deed Records of Dallas County, Texas: THENCE West along the North line of said Railroad right of way for a distance of 400.% feet to an iron rod for corner; THENCE North for a distance of 472.99 feet to an iron rod for corner in

Railroad, a 100.00 foot right of way with the West line of Dooley Road,

the South line of Lindbergh Drive, a 60.00 foot right of way: THENCE East for a distance of 400.96 feet to an iron rod for corner at the intersection of said South line of Lindbergh Drive with the West line

THENCE South 00 degrees 06 minutes 35 seconds East along said West line of Dooley Road for a distance of 472.99 feet to the PIACE OF BEGINNING. CONTAINING 189,437.2249 square feet or 4.3488 acres of land.

NOW, THEREFORE, KNOW ALL MEN BY THESE PRESENTS:

THAT I do hereby adopt this plat as PAUL LEWIS ADDITION, an addition to the City of Addison, Dallas County, Texas: and do hereby dedicated to the public use and benefit forever all streets and alleys shown on the plat for all public purposes including but not limited to all street purposes and the right of the City of Addison and its assigns to lay, install, operate, replace, repair, remove and resonstruct any and all public utilities including but not limited to all water lines, sanitary sewer lines, drainage and storm sewer canals and lines, gas lines, telephone poles and lines, electrical power lines and appurtenances. The right of the City of Addison to establish grades on said dedicated streets and alleys is hereby granted and all claims for damages which may arise by reason of changing the present surface of said streets to conform to said grades are hereby waived.

The easements shown on the plat are hereby granted and dedicated and reserved for the mutual use and accommodation of the City of Addison and all public utilities desiring to use or using the same for public utilities purposes including but not limited to water lines, sanitary sewer lines, drainage and storm sewer canals and lines, gas lines, telephone poles and lines, electrical power lines and appurtenances. All and any public utility and the City of Addison shall have the right to remove and keep removed all or part of any residences, buildings, fences, trees, shrubs or other growths, improvements or obstructions which may in any way endanger or interfere with the construction, operation or efficiency of the respective utility in, on or under said easement strips. The City of Addison and all public utilities shall at all times have the full right of ingress and egress to and from and upon said easement strips for the purpose of onstructing, reconstruction, inspecting, patrolling, maintaining and adding to or removing all or part of its respective systems, without the necessity at any time of procurring the permission of anyone.

I do further dedicated to the public use and benefit forever all parks, squares, parkways and all other public uses and dedications shown on the face of the

All lots in the subdivision shall be sold subject to the building lines shown on the plat and the minimum building set back lines in all City of Addison ordinances.
