## OWNER'S CERTIFICATE

STATE OF TEXAS COUNTY OF DALLAS

WHEREAS, BELTWOOD NORTH VENTURE is the owner of a tract defined as Lot 8A and 8B and UNIVERSAL INVESTMENTS, INC., is the owner of a tract defined as Lot 8A, all in the George Syms Survey, Abstract No. 1344, Beltwood North, Phase 2, an addition to the particularly described as follows:

Commencing at the northeast corner of Beltwood North, Phase 2; Thence S 89°46'00"W, 202.70-feet along the north addition line of Beltwood North, Phase 2 to the Point of Beginning:

THENCE S 20°36'10"E 576.04-feet along the common line between Lot 7 and Lot 8 to an angle point being on the east line of Beltwood North, Phase 2;

THENCE, South, 98.26-feet along the east line of Beltwood North Phase 2 to a point for a corner being on the common line between Lot 6 and Lot 8;

THENCE, West, 263.45-feet along the common line between Lots 6 and 8 to a point for a corner on the east line of Midway Circlesaid point being the beginning of a curve to the left having a central angle of 4°38'05", a radius of 360.00-feet and a tangent length of 14.57-feet that bears N.15°58'05"W;

THENCE, 29.12-feet along the east line of Midway Circle to the end of curve;

THENCE N 20°36'10'W, 274.55-feet along the easterly line of Midway Circle to the beginning of a curve to the left having a central angle of 69°37'50", a radius of 80.00 feet and a tangent length of 55.63-feet;

THENCE 97.22-feet along the easterly line of Midway Circle to the end of curve;

THENCE, S.89°46'00'W., 180.00-feet along the north line of Midway Circle to the beginning of a curve to the left having a central angle of 2°43'22'', a radius of 275.36-feet and a tangent length of 6.54-feet;

THENCE, 13.09-feet along the north line of Midway Circle and the curve to the left to the end of curve;

THENCE, N.00°14'00"W., 300.30-feet to a point for corner on the north line of Beltwood North, Phase 2;

THENCE, N.89°46'00"E., 435.99-feet along the north line of Beltwood North, Phase 2 to the Point of Beginning and containing 5.674 Acres of land.

NOW, THEREFORE, KNOW ALL MEN BY THESE PRESENTS:

THAT BELTWOOD NORTH VENTURE AND UNIVERSAL INVESTMENTS, INC., do hereby adopt this plat designating the herein described property as Replat of LOT 8, BLOCK B. BELTWOOD NORTH, PHASE 2, an addition to the City of Addison. Texas and do hereby dedicate to the public use forever the streets and alleys shown thereon. The easements shown thereon are hereby reserved for the purposes as indicated, The utility and fire lane easements shall be open to the public, fire and police units, garbage and rubbish collection agencies and all public and private utilities for each particular use. The maintenance of paving on the utility and fire lane easements is the responsibility of the property owner. No buildings, fences, trees, shrubs, or other improvements or growths shall be constructed, reconstructed, or placed upon, over or accross the easements as shown. Said easements being hereby reserved for the mutual use and accomodation of all public utilities using or desiring to use same. All and any public utility shall have the right to remove and keep removed all or parts of any buildings, fences, trees, shrubs, or other improvements or growths which in purpose of constructing, reconstruction, maintenance or efficiency of its respective systems on the easements for the purpose of constructing, reconstructing, inspecting, maintenance or efficiency of its respective systems without the necessity at any time of procuring the permission of anyone. Any public utility shall have the right of ingress or engress to private property for the purpose of reading meters and performing any maintenance and service required or ordinarily performed by that utility.
